The board (the "**Board**") of directors (the "**Directors**") of the Company wishes to inform the shareholders of the Company (the "**Shareholders**") and potential investors that, based on the information currently available to the Board and a preliminary review of the unaudited consolidated management accounts of the Group for the year ended 31 March 2023 ("**FY2023**"), the Group is expected to record a net profit of about HK\$5.0 million for FY2023 as compared to that of approximately HK\$10.9 million for the year ended 31 March 2022.

The aforesaid decrease in net profit of the Group was mainly attributable to the combined effect of (i) a decrease in gross profit of approximately 8% for FY2023 as compared to that for the year ended 31 March 2022 as a result of the increase in material costs and direct staff costs for the Group's projects; (ii) the negative impact arising from the spread of COVID-19 pandemic worldwide during FY2023, leading to postponement and/or slowdown in certain construction projects in Hong Kong and Macau; and (iii) an increase in administrative expenses arising from the increase in staff costs and depreciation expenses for the newly acquired property and equipment.

The Company is still in the process of finalising its annual results for FY2023. The information contained in this announcement is only based on the preliminary assessment made by the Board on the unaudited consolidated management accounts of the Group for FY2023 with reference to the information currently available, and such information has not been reviewed by the Company's auditors or the audit committee of the Company and may be subject to adjustments where necessary. Shareholders and potential investors are advised to peruse with care the annual results announcement of the Company for FY2023, which is expected to be released on 27 June 2023.
